# Rail freight picks up after steep decrease in April

New Delhi, June 19

**FREIGHT LOADING BY** the Indian Railways has picked up in May and further in June, after falling to a very low level in April, the lockdown month. In the first 17 days of June, the national transporter carried freight just 9% lower than the year ago period, as compared with 22% lower from year ago in May and 35% in April.

Railway Board chairman Vinod Kumar Yadav said freight loading was 65 million tonne in April as against 101 mt in the year ago month.

In May 2020, freight

trains carried 82 mt of goods as against 105 mt in May last year and till June 17th this year, freight loading has been 52 mt as compared to 57 mt in the corresponding period last year.

Between April-June 2020, trains have carried 200 mt of freight as compared to 262 mt in the same period last year. Yadav attributed this to a strong recovery in freight loading

of coal, steel, fertilisers, steel, iron ore and other essential commodities like foodgrains.

Yadav said freight earn-

ings target for FY21 was ₹1,30,000 crore and that the Railways was confident of surpassing this with the pick-up in operations.
